Customers enrolled in our auto-pay program (service charges are automatically billed each time services are rendered) receive an additional 5% discount on collection services. Customers must enroll at the time of service agreement execution in order to receive this 5% discount, however, may enroll in our auto-pay program at any time.

Customers electing to receive paper based invoices will be charged an additional \$1.95 processing fee per invoice.
